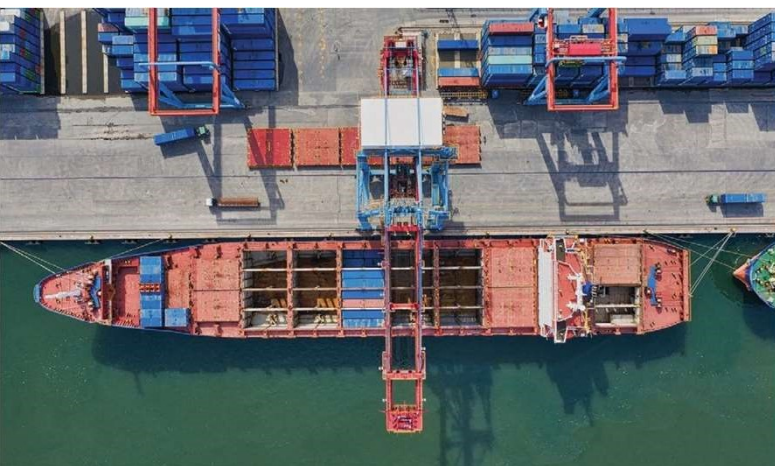

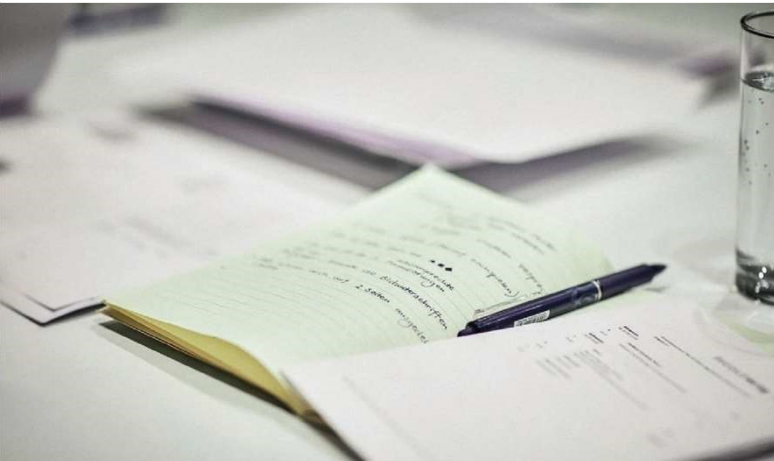


## CUSTOMS CLEARANCE

ACT manage all Mauritanian operations of express deliveries and operate a dedicated fleet of vehicles, offering secure and efficient parcel delivery and collection services.

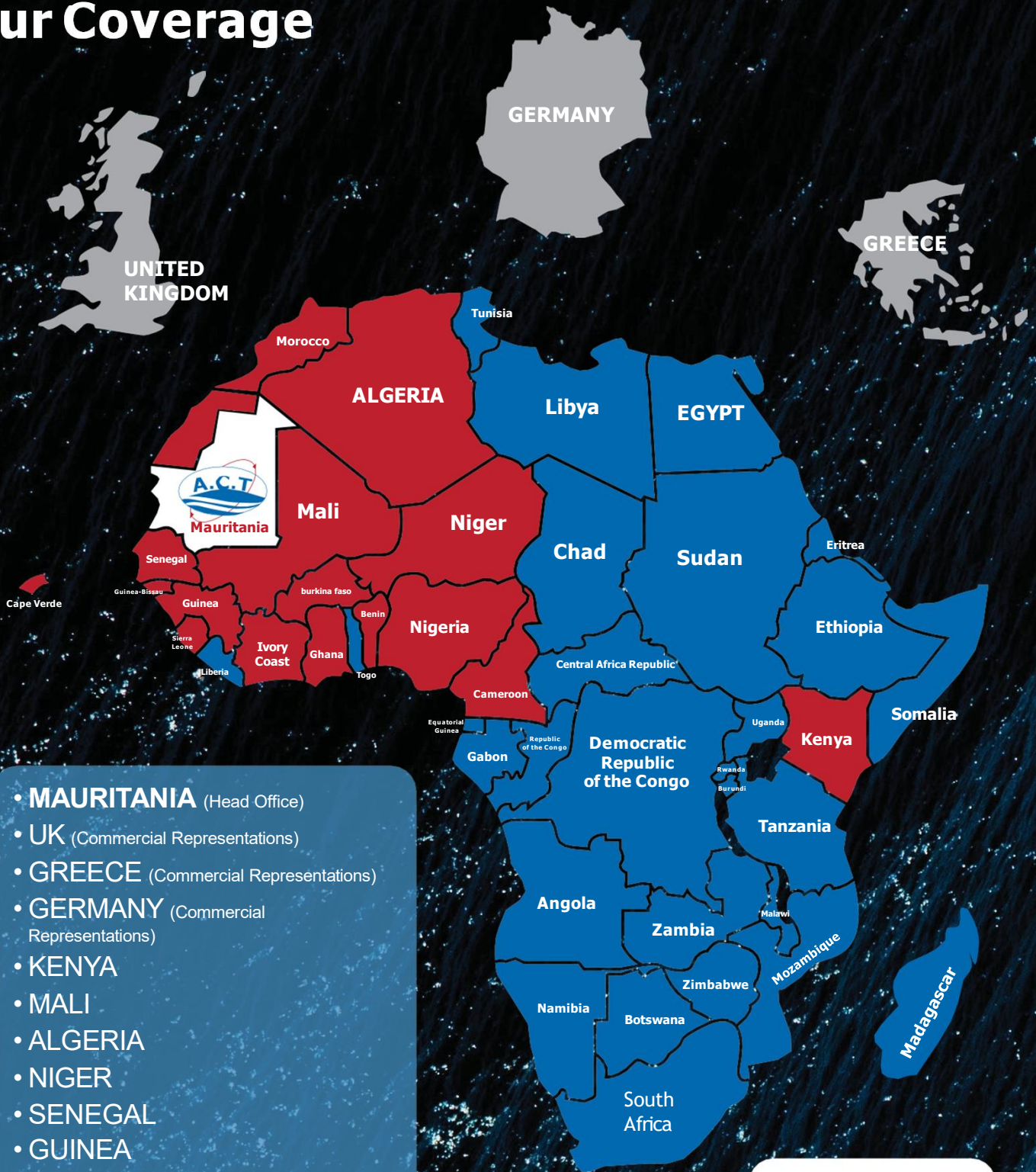


## MEET & GREET SERVICES
